#### **REPORTS**

## a) Administration and Marketing

A meeting to be arranged with Midlands Funds Management to review their continued sponsorship of Bowls Taranaki and the Taranaki Men's Open Fours.

Financial documents to be put together and a meeting scheduled to review the Taranaki Open Fours for 2025.

#### b) Events

After receiving correspondence it was noted, that Clubs should be aware that their smoking areas need to be away from the greens where people are playing. All players and visitors should smoke in these areas for Centre events.

It was moved by Val McEldowney/Chris Commane that "A Women's Centre Fours Title be played for. A minimum of 20 entries required for the Centre Fours to be eligible to count towards a Centre Point towards your Gold Star." **CARRIED** 

This Women's Centre Fours tournament will be played at the same time with the same Conditions of Play as the Men's Centre Fours and hosted in the Southern Division.

It was moved by Grant Hassall/Val McEldowney that "the Men's and Women's Open Triples be shortened to 18 ends per game to be consistent with the Bowls NZ Champion of Champion's events."

# c) High Performance

A meeting of the Selectors had occurred after the Junior Hexagonal and Octagonal. Congratulations to our Men's team, winners of the Junior Hexagonal. Plans are in place for our teams to participate in the National Intercentre.

#### d) Youth

lan Lewis met with Cole Drinnan, the Rangatahi Lead for Bowls New Zealand. It was arranged that he will visit Taranaki from the 13<sup>th</sup> to 17<sup>th</sup> of October 2025. Cole is to contact schools all around the province to introduce Lawn Bowls to interested students and classes. Bowls Taranaki to assist with volunteers and resources.

#### e) Membership/Club Engagement

It was noted that, no club is able to simply nominate a person or team to represent them at Champion of Champion's events. Clubs must ensure a Club event is held to determine their winner and the winning scorecard is supplied to the Centre Office when entering.

# Women's Junior Hexagonal

Bowls Kapiti asked for dispensation to field a senior player prior to the start of the Junior Women's Hexagonal held at West End. A report to be sent to all Centres detailing what occurred, how it was handled and the default which was recorded by Kapiti for fielding an ineligible player. This letter to be sent to ensure that all Centres improve their procedure

for selecting sides, and to ensure a fair competition remains for all 8 Year and Under players involved.

# First Year Singles

# Taranaki v Whanganui Mid Winter Fixture

A pre-season fixture to be held between Taranaki and Whanganui at the Indoor Stadium at Paritutu. Stadium has been booked for the 19<sup>th</sup> & 20<sup>th</sup> of July. Centres will field a Junior and Senior Men's side playing on the Saturday and a Junior and Senior Women's side playing on the Sunday.

## Player of the Year Points

It was clarified that Player of the Year points awarded for success at Bowls New Zealand events are for the National Open Championship events only and that only Full International Honours receive points. Handbook to be updated to make this more clear.

## **Bowls New Zealand Champion of Champion Mixed Pairs**

Currently we use the Open Mixed Pairs event as our qualifier for the Bowls New Zealand Champion of Champion's Mixed Pairs. Clubs to be consulted as to whether to retain this method of qualifying, or for each club to host their own club mixed pairs event and a Champion of Champion's event to be held.

#### **Bowls Taranaki Constitution**

The meeting was closed at 12.15pm.

We have reviewed the example constitution provided by Bowls New Zealand, and Grant Hassall has contacted Bowls New Zealand for clarification on some matters. Bowls Taranaki are happy to keep with a two year rotation for appointed Board Members. We aim to have the Constitution ready for clubs to approve at our AGM.
